
#### **Back Clip Installation**




### **Back Clip Installation**

The SPD mini has two power input ports:

1. TA4 Port: Connect an external power source or smart battery to the TA4 port. Turn on the power switch, and the screen will light up to display power status information.



2. USB-C Port: Connect the USB-C power cable from an external power source or smart battery to the USB-C power input port on the device. Turn on the power switch, and the screen will light up to display power status information.



## **Indicator Light Explanation**

#### TA4 Power Supply:

(1) Red Light Steady On: < 13V

(2) Green Light Steady On: > 13V

(3) Red Light Flashing Slowly: > 18V

#### **PD Protocol Adapter:**


TYPE-C Power Supply:

(1) Red Light Steady On: 9V, 12V


(2) Green Light Steady On: 15V


#### **Non-Smart Battery Interface**




#### **USB-C Input Interface**

### Input Overload (Overvoltage)

When the power input voltage reaches or exceeds 18V, the screen will display "Overvoltage" to indicate an input overload. At this point, all output power transmission will be stopped.
